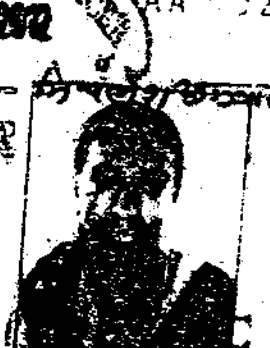

2. 3. That the donation towards corpus will not be treated as income that the trust shall have the inherent right to declare any donation as corpus fund to meet expenditure either of recurring in nature of otherwise, any income generated for corpus may be retained as part of the corpus fund or maybe used to meet the expenses of the trust as the need may be.
4. OFFICE OF THE TRUST;
The registered & Administrative office of the trust shall be R/O 3/1348/3, Bajoria Marg, Saharanpur (U.P.). The same can be shifted to any other premises or land acquired to be acquired for the purpose of the trust in any other part of India with The decision of the trustees of the other part.

5. JURISDICTION OF COURT;

If any dispute, differences and/or claims arising out of this or any breach thereof, including, without limitation, any claim that said rules, or any part thereof, is invalid, illegal or otherwise voidable or void, or the enforcement of any right or obligation which by its nature, survives the expiration or termination hereof, shall be settled by Arbitration, in accordance with the provisions of The Arbitration & Conciliation Act, 1996.

6 SCOPE OF THE TRUST.

The Trust for its purpose can be shifted or set up in any part/ all over India.

7. AIMS AND OBJECTS OF THE TRUST:

(a) To provide, promote and restricting education facilities in the field of commerce, medical, engineering, management, computer science, technical subject, professional and vocational courses nursery, primary, middle and high/ Sr. secondary education for the needy students, intellectuals and other persons of the society.

(b) To engage teachers, professor, instructors, professionals management personnel Technical advisor and expert of good moral character and having capability to impart Efficiently and economically up to date knowledge to student in medical, engineering, management, computer science, all vocational courses, nursery, primary, middle and higher /Sr. secondary education intellectual and other pursue for the benefit of general public.

(c) To establish, acquire, construct, maintain and run group of faculties university Different fields, colleges, institution, polytechnic for imparting all sorts of education in the field of medical, paramedical, engineering, management, vocational course and nursery, primary middle and higher/ Sr. secondary education in India or outside India to children, boys, girls, and to men and women.

(d) Helping and setting up yoga and meditation centers.

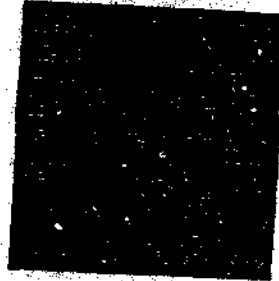

(f) To do all such acts and activities for the upliftment of schedule castes, schedule tribes and other backward and minority classes of people.

(g) To accept donation, grants, presents and other offerings and to deal with the same for the purpose of the trust.

(h) To charge moderate tuitions fees and otherwise recoup themselves for the outlay and expenses incurred in the upkeep and maintenance of the institutions established under this deed.

(i) To train equip pupils so as to be self supporting in an honorable and decent way of life so as to develop into good, healthy and progressive citizens.

(j) To develop discretionary conduct and a habit to observe the rule of law self resident.

(k) To bring out, encourage and develop the inventive research faculties of the pupils and teachers and to afford opportunity for research work in medical science, industrial and information technology and other allied areas of these types.

(1) in the event of the trustees intending to withdraw from the trust or submits his resignation the same may be allowed by the board of the trustees by simple majority decision and the prior approval of the chairman of the trust.

(m) Notwithstanding any thing contained in any other provision of this deed, Sh. Ashok Kumar Aggarwal continue as the chairman for the board during his pleasure and shall not be liable to be removed. Sh. Vikas Aggarwal Secretary and Mrs. Aditi Aggarwal Treasurer will hold the office of trustee for life long i.e. they will be the permanent trustees. The term of the other trustees will be for

8.. (a) The post of chairman shall be occupied by Shri Ashok Kumar Aggarwal, S/O Shri Chetan Das trustee of one part.

(b) The post of secretary shall be occupied by Shri. Vikas Aggarwal S/O Shri Ashok Aggarwal trustee of the other part.

(c) The post of treasurer shall be occupied by Smt. Anji Aggarwal W/O Shri. Vikas Aggarwal trustee of other part.

9. POWER & FUNCTIONS OF THE CHAIRMAN OF THE TRUST;

(a) the director, chief coordinator and all other executives shall be appointed by the chairman of the trust to handle the objective of the trust or institution of the trust to the best of all respect. The chairman of the trust shall be the link between the executive officers viz. chief coordinator, director etc. and the board of trustees etc. and will be having all powers which any trustee or trustees jointly or severally or any officer called by whatever name can exercise in their power for interest of the trust and for fulfillment of any or all aims and objects of the trust.

(b) the investment of the said trust fund or the interest or income thereof any part thereof shall always be kept in the name of the trust. If it is not possible or permissible to do so then in the name of all or such number of trustees as may be decided by them from time to time and in case of account and deposit as aforesaid, the same shall be dealt with of operated upon in such manner as may be decided by the said trustees from time to time and if necessary they said trustees may give a power of attorney to any schedule bank to realize the income of the said trust found and to collect the same on behalf of the said trustees.

(c) Shri Ashok Kumar Aggarwal shall be the chairman of the trustees of this trust. He shall be the permanent chairman of the trust. The chairman shall have power to appoint majority of the trustees of the trust.

(d) all the investment of the trust shall be made with the consent of the chairman of the trustees. The trustees shall be entitled to frame such roll for the management and the administration of the trust as they think fit.

(e) on every appointment of the trustees they said trust fund shall if and so far as the natures of the property and other circumstances shall require of admit be transferred so that the same may be vested in the said trust or trustees or trustee for the time being.

(f) All the decisions of the trustees whether permanent or temporary has/have to be approved by the president. The president would be having powers to veto any of the decisions of the trustees whether permanent or temporary. The decision of the president would be final and can not be challenged.

10. POWER AND FUNCTIONS OF SECRETARY

(a) He can take decision regarding amount received/deposited by the Trust, source and amount and through property which is under supervision of Trust and all the important issues/ matters which are related to managing of Trust Fund.

(b) To accept all source of gifts, donation, contribution of any type.

(c) To direct routine work and manage complete income and expenditure, to hold records and and original documents of moveable - immovable property of Trust, to correspond with Govt. or other committees/departments when required.

11. POWER AND FUNCTIONS OF TREASURER;

- To maintain record of property of Trust, arrange audit, to get the record approved in annual meeting to inform secretary about expenses.
- The account of Trust will be opened in any scheduled Bank, or Banks, Co-operative Bank or Banks and it will be operated by any two out of the signatures of President/ Chairman or Secretary or Treasurer or any two authorized by Chairman among the Founder Trustees.

12. POWER AND FUNCTION OF MEMEBERS;

Any four members including office bearers may request chairman / secretary for calling board of trustee meeting with in one week's time of emergency meeting. The chairman / secretary will participate in the discussion for resolving matters of interest of the trust.

13. POWER AND FUNCTION OF TI-FI BOARD OF TRUSTEES;

- (1) All the policy decision shall be taken by the board of trustees and conveyed to the chairman for its implementation and final approval.
- (2) The chairman shall act the decision of the board implementation through Director/ Chief coordinator or any other incumbent employed working in the trust. In case of any dispute arising out of any decision, the verdict of "chairman" shall be considered as full and final and binding to the board of trustees.
- (3) Without prejudice to the General Power conferred by the last proceeding clause and other powers conferred by these present's it is hereby expressly declared that the Trustees shall have the following powers:
 - (a) To pass accounts of the Trust and consider any recommendation made in regard thereof at a General Meeting.
 - (b) To pay the expenses incurred in carrying out the objectives of the trust and to make and give receipts, releases and other discharges on behalf of the trust

(c) To acquire for the trust and land, property, rights, or privileges on such terms and conditions as they deem fit.

(d) To invest in shares and stocks of companies, FDR's of Bank, units etc. and deal with moneys or the trust in such a manner as they deem fit and from time to time to vary or release such investments in the interest of Trust subject to the rules, and regulations under Income Tax Act, 1961 or under any or all other Govt. statutes.

(e) To enter into and secure the fulfillment of any contracts or engagements of behalf or the trust, compound abandon any legal proceedings by or against the Trust and to refer any matters, claims or demands or to arbitrate, observe and perform the awards.

(f) To set up independently or in collaboration with the Foreign Institution or University, constitute and organize local branches in India or abroad of the Trust and such manner and on such terms as may be considered necessary in the interest of the Trust and to constitute committees consisting of two or more personnel not necessarily members of the Trust and vary the same and delegate to them of such powers as may be considered for the purpose.

(g) To employ instructor, and personnel as may be considered necessary of the paid purpose and to employ skilled workers and professionals, advisors to carry out the objectives of the Trust to pay such remuneration as may be considered expedient.

(h) To accept grants, donations and contributions in cash or in kind from other public bodies, corporation associations, institutions, companies or individuals within India or abroad for the purpose of the Trust in such conditions as may be agreed to by the Chairman or Board of Trustee.

(i) To provide for funds for all or any objectives of the Trust in such manner as may be considered expedient.

- (j) To draw, accept, endorse discount, execute and issue promissory notes, bills of exchange and other negotiable transferable instruments in the interest or trust.
- (k) To purchase, take on lease or in exchange, hire or otherwise acquire any movable or immovable property, and in particulars any land, buildings, workshops, motor car concerned with privileges necessary for or consistent with the purpose of the Trust and to construct, erect, alter, improve, and maintain any building and to manage, develop, sell, demise, let mortgage, dispose or turn to account or otherwise deal with the same and also to sell the undertaking to Trust for cash or any other consideration with a view to promote the objectives of the Trust.
- (l) To pay all expenses, preliminary or incidental to the formation of the Trust and its registration.
- (m) To establish, support or aid in the establishment of trust institutions, funds and Trust, calculated to benefit employees or employees of the Trust or the dependants or connections or connections of such persons and to grant superannuation benefits and allowances and to make payments towards insurance of such persons.
- (n) To make rules and regulations and bye-laws for conducting smoothly and successfully the affairs of the Trust in a better and planned way and to amend or alter the same.
- (o) To appoint or make provision for the appointment of any person.
- (p) To borrow or raise or secure payments of moneys and also to lend money either with or without security, in accordance with rules and regulations and all statutes application to the Trust.
- (q) Generally to do all such things as the Trustees may consider expedient for the purpose or carrying out the objectives or the Trust.

(t) Trustees are empowered to fulfill the objects of the Trust and to do all other things under the name and style of the Trust i.e. "GLOBAL EDUCATIONAL TRUST" or to open separate institution independently or in collaboration with Foreign institution to be under any name and style to fulfill the aims and objects of the Trust.

14. RULES OF THE TRUST

(a) Every meeting of the Board of Trustees shall be chaired by the Chairman and his absence Secretary shall chair the meeting.

(b) Such a meeting shall be held once in three months or within a period as decided by the Board of Trustees.

(c) Every two members of the Board of Trustees present in person shall constitute a quorum at any meeting of the Trust.

(d) Chairman may call any requisition in writing a meeting of the Trust at any time.

(e) For official purposes, each year, shall be deemed to commence from 1st April and terminate on 31st March.

(f) (i) Each member of the Board of Trustees shall have one vote.

(i) To acquire on lease or by purchase or otherwise any moveable properties including pieces of land or built properties thereon of any kind under any name and style for the use of Trust and fulfillment of its objectives.

(j) To manage, sell, transfer, let out by way of Tenancy, lease, license or otherwise dispose of or deal with the assets/ properties of any kind both moveable or immoveable belonging to the trust.

(k) To enter into any agreement or arrangement with any other Society Foundation, or any other party having any legal entity or any individual for the smooth functioning and achievements of the objectives of the trust in a better way.

(l) To take up any other activities as deemed appropriate towards public interest as and when decided by the Trustees.

(m) To receive and maintain in a fund or funds and to administrator and apply the income and principal thereof for the furtherance of the objects of the Trust and to do all such acts and things which are incidental and

- (e) The board of trustees or chairman duly authorized by all the above trustees shall have power to appoint in writing a person as an additional trustee. However, in no case total number of trustees shall exceed eleven.

- (j) The surviving or continuing Trustees shall have the right to act not withstanding any vacancy in their board PROVIDED TO WEAVER that if the number of trustees shall fall below three (the minimum fixed by the presents), so long as the number is below the said minimum.
- (k) On an new Trustee being appointed and in signing the register to this effect, he shall there be subjected to all the duties of Trustees with effect from that date.

16. RECORDING OF PROCEEDINGS :
